USDA Needs Solutions, Not Surveys

WORC delivers letter to USDA urging them to close loophole which allows imported beef and pork to be labeled "Product of the USA"

Billings, MT -- Yesterday, the Western Organization of Resource Councils (WORC) submitted a letter to USDA urging the agency to stop allowing imported beef and pork to be labeled "Product of the USA". USDA is requesting comments from the public on its plan to do a survey by April 4, 2022. According to their website, the survey will determine "consumer awareness and understanding" of the labeling along with willingness to pay. WORC asserts that a survey is not necessary, but the end to voluntary "Product of the USA" labeling is.

Congress repealed mandatory Country-of-Origin Labeling (COOL) rules for beef and pork in 2015 after a World Trade Organization ruling. This resulted in rules for voluntary Product of the USA labels going into effect. Under current labeling rules, imported beef or pork from anywhere in the world can have a "Product of the USA" label, as long as it is packaged in the United States.

Gilles Stockton, rancher from Grass Range, MT and member of Northern Plains Resource Council said, "The simple and ethical thing for USDA is to disallow the use of the label unless it is in fact a product of the USA. If a beef importer wants to claim that the meat in question had been repackaged in the USA, well they can say so. Nothing is stopping them. But repackaging and then claiming that makes it a "Product of the USA" is fraud."

"In addition to truth in labeling, we must also strengthen antitrust law enforcement by breaking up monopoly power, stop subsidizing industrial ag, and stop favoring larger plants over small processors. Fixing the Product of the USA loophole is one step towards leveling the playing field for producers,"said Kathryn Bedell, rancher from Grand Junction, CO and member of Western Colorado Alliance.

"Americans have the right to know where their food comes from," **said David Schwalbe**, **rancher from Bismarck**, **ND and member of Dakota Resource Council**. "An honest label protects our food security and supports U.S. cattle ranchers and producers for the high quality meat they produce. We are calling on USDA to get to work and fix the label immediately."
